Our 5,000 employees are dedicated in providing world class medical care to people from across Ireland. We will continue to develop our healthcare facilities and services in the future to provide the best possible care to our patients and their families".

"We will have no role in the future of the new independent charity, the St. Vincent's Healthcare Group, St. Vincent's Holding CLG or the new National Maternity Hospital," she confirms. We will continue to care for people who are sick and/or poor, those nearing the end of life, people who are homeless, refugees and those who are victims of human trafficking as well as carrying on our work to develop and deliver education programmes.
