**Reports to:** Reports and is accountable to the relevant Clinical Director **and** Departmental Clinical Lead.

**Department Information:**

The Department of Orthopaedics in SVUH, staffed by 6 surgeons, provides an Orthopaedic and Musculoskeletal regional trauma services to areas including South City Dublin, South County Dublin, Co. Wicklow and parts of East Carlow and North Wexford – giving a ratio of 1 WTE surgeon per 100,000 population. There is 24/7 on-call service and daily consultant led trauma operating lists which allows for prompt delivery of treatment to patients presenting through the ED in SVUH, St. Columcille's and St. Michael's. By arrangement all blue light emergencies are directed directly to SVUH. Fracture Clinics run daily in SVUH, three times per week in St. Michael's Hospital and twice weekly in St. Columcille's Hospital, resulting in 10 consultants led trauma clinics per week in the service over the three sites. Specialty clinics including Hand/Upper limb, Joint replacement, Tumour and Spine are also provided. National and supra regional services are provided in Bone Tumour, Hip Arthroplasty revisions, Elbow Replacement and Chronic Wrist pain. Elective Orthopaedic surgical patients are referred from clinics in the base hospitals to Cappagh National Orthopaedic Hospital. All 6 Surgeons in the unit have elective operating sessions in Cappagh National Orthopaedic Hospital.

**Key Duties and Responsibilities:**

- To participate in development of and undertake all duties and functions pertinent to the Consultant's area of competence, as set out within the Clinical Directorate Service Plan and in line with policies as specified by St. Vincent's University Hospital, Cappagh National Orthopaedic Hospital and Children's Health, Ireland.
- To ensure that duties and functions are undertaken in a manner that minimises delays for patients and possible disruption of services.
- To work within the framework of the hospital and/or levels of service (volume, types etc.) as determined by St. Vincent's University Hospital, Cappagh National Orthopaedic Hospital and Children's Health, Ireland. Service planning for individual clinical services will be progressed through the Clinical Directorate structure or other arrangements as apply.
- To co-operate with the expeditious implementation of the Disciplinary Procedure.
- To formally review the execution of the Clinical Directorate Service Plan with the Clinical Director / Employer periodically. The Clinical Directorate Service Plan shall be reviewed periodically at the request of the Consultant or Clinical Director / Employer. The Consultant may initially seek internal review of the determinations of the Clinical Director regarding the Service Plan.
- To participate in the development and operation of the Clinical Directorate structure and in such management or representative structures as are in place or being developed. The Consultant shall receive training and support to enable him/her to participate fully in such structures.
- To provide, as appropriate, consultation in the Consultant's area of designated expertise in respect of patients of other Consultants at their request.
- To ensure in consultation with the Clinical Director that appropriate medical cover is available at all times having due regard to the implementation of the European Working Time Directive as it relates to doctors in training.
- To supervise and be responsible for diagnosis, treatment and care provided by non-Consultant Hospital Doctors (NCHDs) treating patients under the Consultant's care.
- To participate as a right and obligation in selection processes for non-Consultant Hospital Doctors and other staff as appropriate. The Employer will provide training as required. The

Employer shall ensure that a Consultant representative of the relevant specialty / sub-specialty is involved in the selection process.

**Probationary Period:** A Consultant who currently holds a permanent Consultant appointment in the Irish public health service will not be required to complete a probationary period should (s)he have done so already.

A Consultant will not be required to complete the probationary period where (s)he has for a period of not less than 12 months acted in the post pending its filling on a permanent basis.

**Pension Scheme:** The candidate will be entered into one of the Hospital Superannuation Schemes.

**Working Hours:** The Consultant is contracted to undertake such duties / provide such services as are set out in this Contract and agreed work schedule in the manner specified for 37 hours per week (19 hours at St. Vincent's University Hospital, 10 hours Cappagh National Orthopaedic Hospital & 8 hours at Children's Health Ireland). To support the Employer in the delivery of extended consultant-provided services the Employee's core weekly working hours will be scheduled to occur between 8.00 am and 10.00 pm on rostered Mondays to Fridays and between 8.00 am and 6.00 pm on rostered Saturdays.

**Annual, Conference, Course leave:**

All leave or planned absences, other than those described in Clause 19.3 'Sick Leave', Terms and Conditions of Consultant Contract must have prior approval from the Clinical Director / Employer.

The Consultant's annual leave entitlement is 30 working days per annum and as determined by the Organisation of Working Time Act 1997.

**Sick leave:**

The Consultant may be paid under the Sick Pay Scheme for absences due to illness or injury. Granting of sick pay is subject to a requirement to comply with the Employer's sick leave policy.

**Travelling & Subsistence Expenses:**

Travelling and subsistence expenses necessarily incurred by a Consultant in the course of duty shall be met on the basis applicable to persons of appropriately senior status in the public sector.

**External Work (Private Practice):**

**Medical Council Registration**

**Superannuation/Retirement:**

(a) You will be covered by the terms of the relevant pension scheme as set out in Sections 5 & 6 of DPER circular 19/2012. (c) Consultants newly appointed on or after 1st January, 2013 or persons returning to public service employment after a break of more than 26 weeks will be members of the Single Public Service Pension Scheme. The Single Scheme provides for CPI-linked defined-benefit pension awards based on career-average pay. Minimum pension age will be linked to the State Pension age (66 years initially, rising to 67 in 2021 and 68 in 2028). Pension benefits for new entrants will accrue on a standard basis (i.e. one year's credit for one year's service up to a maximum of 40 years' service) while normal abatements of pension provision will apply to all public sector posts. Compulsory retirement age for most members will be 70 years.

### **Additional Information**

#### **St. Vincent's University Hospital**

St. Vincent's University Hospital is a 614 bedded teaching hospital. The catchment area has a population of approximately 360,000 people and is situated in Dublin Mid Leinster/South Dublin Hospitals Network. The hospital provides a comprehensive range of medical, surgical, radiology, pathology and other services for this region and, at the present time for some areas outside it.

The hospital is part of the teaching facility at University College Dublin and undertakes undergraduate and postgraduate teaching and training. The appointee will have the opportunity of participating fully in all the research and academic activities of the Department of Trauma and Orthopaedic Surgery and will be encouraged to develop their own research interests. They will also be expected to participate in teaching with special emphasis on undergraduates. The appointee will be a member of the Medical Board of St. Vincent's University Hospital.

The appointee will have full access to all the academic facilities available at the St. Vincent's University Hospital site and through its association with the School of Medicine and Medical Sciences, University College Dublin.

#### **Cappagh National Orthopaedic Hospital**

Cappagh National Orthopaedic Hospital is Ireland's major centre for elective orthopaedic surgery. Cappagh has been the pioneer of Orthopaedic Surgery in Ireland and is now the biggest dedicated Orthopaedic hospital in the country.

Cappagh National Orthopaedic Hospital is a Voluntary Hospital founded in 1908 under the care of the Religious Sisters of Charity. It was once renowned for its 'Open Air' wards and for its surgical treatment of children with TB from the 1920s. It is now an elective hospital with 160 beds, 11 of which are semi-private. The hospital provides the full range of Orthopaedic services including Major Joint Replacement (Ankle, Hip, Knee, Shoulder, Elbow, Wrist), Spinal Surgery, Primary Bone Tumour service, Paediatric orthopaedics and Sports Injuries. The Orthotic Unit produces artificial limbs, braces and other aids for patients from all over the country.

The hospital has links with Beaumont Hospital, Children's University Hospital, Temple Street, Connolly Hospital, Blanchardstown, Mater University Hospital, St. Vincent's University Hospital, St. Michael's Hospital, Dun Laoghaire and St. Columcille's Hospital, Loughlinstown.

## **Children's Health Ireland**

Children's Health Ireland (CHI) comprises of the three children's hospitals at CHI at, Dublin 12, CHI at Temple Street, Dublin 1 and CHI at Tallaght, Dublin 24 and the Paediatric Outpatients and Urgent Care Centre, CHI at Connolly Hospital, Dublin 15. The new OPD and Emergency Care Unit in Tallaght opened in Nov 2021. This post will be based at CHI at Crumlin, pending the opening of the New Children's Hospital but will be expected to work with colleagues to oversee patients in all CHI sites.

CHI governs and operates local paediatric services for the Greater Dublin Area and all national paediatric specialist services, some of which are on an all-island basis.

Orthopaedic Surgery is delivered in Children's Health Ireland at Crumlin by 8 consultants with a team of 10 Registrar/SpRs, and 2 SHOs and 2PAs. Orthopaedic Surgery is also delivered in CHI at Temple Street by a separate team of consultants and NCHDs. The successful applicant will provide all paediatric orthopaedic oncology services for the State thus formalising and structuring the current informal ad-hoc arrangement. The appointee will attend CHI at Crumlin on a weekly basis to participate in paediatric oncology MDTs thereby enabling the post holder to actively participate in the initial consultation and the development of the relevant treatment plan in Crumlin. They will also provide 1 outpatient clinic per week in CHI at Crumlin.

### **Confidentiality:**

During the course of employment staff may have access to, or hear information concerning the medical or personal affairs of patients, students, staff and / or other health service business. Such records and information are strictly confidential and unless acting on the instruction of an authorised officer, such information must not be divulged or discussed except in the performance of normal duty.
