Job title / Grade: Senior Medical Scientist – Molecular Pathology
Reports to: Chief Medical Scientist Histopathology & Consultant Head of Molecular Pathology & Consultant Head of Histopathology Department

Overview:

The post of Senior Medical Scientist is a grade that has specific responsibility for the diagnostic molecular pathology service but also has flexibility for Management to identify the areas of particular responsibility across Histopathology according to the prevailing service needs. The Senior Medical Scientist responsibilities include:

- Leading role in the ongoing development of the diagnostic Molecular Pathology Cancer Service in line with best practice
- Lead in the maintenance of the Molecular Pathology service which is patient centred and which measures and audits performance and user satisfaction.
- Provision of a total molecular pathology diagnostic service supporting the clinical needs of patients
- Implementation and Maintenance of the Quality Management System
- Participate in the implementation of operational processes to the standards of 'best practice' particularly in a quality training capacity

Key Duties and Responsibilities:

- Maintain throughout the hospital awareness of the primacy of the patient in relation to all hospital activities.
- Participate in implementing a diagnostic molecular pathology service that supports the clinical needs of our patients and ensuring that the service is consistent with the mission, vision, values and strategic plan of the hospital
- Participate in training staff as required.
- Participate in the implementation of operational processes to the standards of 'best practice', in order to optimise use of resources.
- Actively participate in the implementation and maintenance of the Quality Management System (QMS). This QMS is patient centred, measures and audits performance and client satisfaction. The QMS complies with ISO 15189 and provides the governance framework for all processes in the department.
- Actively participate in and promote continuing education and research activities consistent with the position.
- Demonstrate behaviour consistent with the values of the hospital.
- The post holder is expected to maintain confidentiality at all times and breaches of confidentiality will be treated under the hospital's disciplinary procedure

Specific Duties and Responsibilities:

The Senior Medical Scientist in Molecular Pathology reports to the Chief Medical Scientist in Histopathology, the Consultant Head of Molecular Pathology and the Consultant Head of Department and with the laboratory management team has the authority and responsibility for the following roles:

- Provision of the molecular pathology service in a senior capacity in the roles assigned and as part of the departmental team.
- Participate in the verification, clinical validation, maintenance and development of the histopathology molecular next generation sequencing (NGS) service and potential future molecular services.
- Educate and train other laboratory staff in the practice of a high quality service.
- Ensure the Control of Process Records is followed
- Participate in implementation and maintenance of the QMS in co-operation with Histopathology and Pathology Management.
- Participate in laboratory meetings, decision making and policy implementation.
- Ensure that authorised SOPs are implemented for all tests and are up to date.
- Ensure that continuous quality improvement is prioritised and achieved.
- Ensure that appropriate External Quality Assessments are performed on all tests and addressed at departmental meetings
- Prepare for external inspections, and co-operate with Histopathology Management in recording, acting on, and closing non-conformances.
- Ensure that the laboratory operates within the QMS, meeting ISO 15189 or JCI accreditation standards where appropriate
- Participate in ensuring that effective safety procedures are in place to comply not only with the Safety, Health and Welfare at Work Act but also within the spirit of the Hospital's mission, vision and values, and that they are known and followed.
- Assist with the Laboratory Management Team in developing procedures to be followed in preventing and managing accidents occurring in the Laboratory area.

The above Job Description is not intended to be a comprehensive list of all duties involved and consequently, the post holder may be required to perform other duties as appropriate to the post which may be assigned to him/her from time to time and to contribute to the development of the post while in office. This document must be regarded as an outline of the major areas of accountability at the present time, which will be reviewed and assessed on an on-going basis.

The Hospital Structure is currently under review and therefore, reporting relationships may change. Similarly, the current SVUH molecular service is evolving and reporting structures may change in the future.

Probationary Period: The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

Pension Scheme: The candidate will be entered into one of the Hospital Superannuation Schemes.

Working Hours: The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

Annual leave entitlement: 30 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one week's notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts

are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

Disability: Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. SVUH reserves the right to remove candidates from specific recruitment panels and retract job offers if satisfactory clearances cannot be obtained or are deemed unsatisfactory.
