### **Key Duties and Responsibilities**

### **Purpose of the Post**

The Medical Physicist team provides scientific support to ensure that the Radiology, Laser and Phototherapy services are delivered safely, effectively, in compliance with all relevant regulations, and to the necessary standards set by professional bodies. The staff grade physicist will undertake a range of clinical and scientific tasks as appropriate to the role. These may include procedures involving ionising and non-ionising radiation. Duties may include assisting in the provision of medical physics services to other hospitals.

#### **Main Duties**

The post holder will:-

- Work through a competency-based training plan.
- Provide medical physics support and perform quality control measurements on diagnostic imaging equipment across variety of ionising and non-ionising modalities.
- Perform quality control in phototherapy and to assist in the provision of scientific support in phototherapy and lasers, as required.
- Assist RPAs in ensuring compliance with SI 30 of 2019.
- Assist MPEs in ensuring compliance with SI 256 of 2018.
- Assist in the calibration of monitoring equipment.
- Perform contamination monitoring, low level gamma and beta counting, image analysis and assist in medical physics aspects of waste management.
- Perform nuclear medicine imaging therapy and laboratory procedures as required.
- Contribute to audits to inform patient management and clinical care.
- Contribute to research projects and conduct individual research.
- Participate in departmental seminars and scientific meetings to disseminate knowledge acquired through study or research.
- Carry out any other reasonable duties to achieve learning and experience that may be required, which are commensurate with the grade and nature of the post
- Undertake other duties to maintain existing services or assist in the development of new services.

- Acquire and maintain a high level of professional competence in the performance of all tests, investigations and measurements carried out
- Interpret and act upon results of tests, investigations and measurements in accordance with departmental policies, procedures and quality systems
- Comment and advise on new proposals and protocols, especially for service improvements
- Assist in the provision of advice to medical, nursing and other healthcare staff on the optimal and safe use of scientific procedures and highly complex equipment, including assisting in the design of new facilities
- Be responsible for the safe use of complex scientific and medical equipment, including recording all maintenance and calibration procedures performed and any corrective actions undertaken
- Use reagents, consumables, hazardous materials and equipment safely and in accordance with Health and Safety policies
- Have a working knowledge of the relevant standards and legislation
- Comply with the requirements of the Health and Safety at Work Legislation
- Comply with quality and governance procedures within the department including risk management and risk mitigation
- Maintain high standards of professional and personal conduct
- Participate in a staff review.
- Retain sufficient flexibility and adaptability in learning in order to ensure full contribution to improving services in response to changing health care needs
- Maintain knowledge of recent scientific developments and undertake supplementary training to develop both knowledge and skills
- Complete mandatory training as required

The above Job Description is not intended to be a comprehensive list of all duties involved and consequently, the post holder may be required to perform other duties as appropriate to the post which may be assigned to him/her from time to time and to contribute to the development of the post while in office. **The appointment is:** Wholetime, Permanent and Pensionable

**Panel:** A panel may be formed to fill upcoming permanent, temporary, whole-time and part-time vacancies over the next 6 months.

**Annual Salary**: as at 01/08/2025 (Physicist, grade 3794) €46,307 - €78,549 pro rata.

<u>Candidates should expect to be appointed on the minimum of the salary range and in accordance with the Department of Finance guidelines.</u>

**Probationary Period:** The appointee shall hold office for a probationary period of six months – The Hospitals Probation and Induction policy will apply.

**Pension Scheme:** The appointee will be entered into one of the Hospitals Superannuation Schemes.

**Working Hours:** The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

**Annual leave entitlement:** 28 working days per annum pro rata. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

**Abatement of Pension (Section 52 of Public Service Pensions Act 2012):** Where a person who is in receipt of a Public Service Pension (e.g. retired on voluntary age grounds) is subsequently appointed to another Public Service post, the Abatement of Pension Regulations apply. **Shortlisting:** Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next state of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. It is your responsibility to ensure that you have access to your mobile voice mails and emails. We recommend that you use an email address that you have regular access to.

Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one weeks' notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

**Disability:** Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)\*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. SVUH reserves the right to remove candidates from specific recruitment panels and retract job offers if satisfactory clearances cannot be obtained or are deemed unsatisfactory.

\* If you lived in any country for 6 months or more from the date of your 16th birthday other than the Republic of Ireland or Northern Ireland you will be required to provide security clearance for each jurisdiction in which you have resided. Your security clearance must be dated AFTER you left that country and cover the entire period of your residence. Seeking security clearances from other countries are the responsibility of the candidate. It is a process which can take an amount of time.
