Title: Staff Grade Occupational Therapist Rotational Post

Responsible to: Occupational Therapy Manager

Role Summary: To provide comprehensive assessment and treatment programmes for patients referred to the Occupational Therapy Department. Staff grade OT rotations include Stroke, Neurology, Acute Medicine, Acute Surgery, Critical Care and Surgical Rehabilitation, Older Persons Care and Hand therapy

Key Duties and Responsibilities:

Clinical:

- Provide Evidence based Occupational Therapy assessment and treatment interventions
- Review patients' progress, record information and report to the multi-disciplinary team through clinical meetings and written reports as required. The standard of report writing should meet the needs of the Freedom of Information Act and departmental standard.
- Provide effective discharge planning and if necessary this may include undertaking home or access visits as appropriate for assessment, treatment and educational purposes.
- As part of each staff grades on-going development and educational each will participate fully in their own self-directed CPD, basic grade rotations, competencies and in-house or external training as applicable.
- Each staff grade will participate in department rotations and the rotation order being at the discretion of the Occupational Therapist Manager so as to best meet service needs.
- Liaise with all members of the multi-disciplinary team within the hospital and community services as appropriate and to co-ordinate treatment programmes as required.
- Engage in supervision meetings with Senior Occupational Therapy staff on a regular basis for the purpose of ongoing clinical and professional development.

Administrative/ Management:

- Responsible for any administrative tasks, as indicated by the Senior Occupational Therapist or Occupational Therapy Manager in relation to patient care and /or departmental procedure.
- Actively participate in the implementation of Hospital and Departmental policies and procedures.
- Keep administrative records and statistics consistent with Occupational Therapy Department policy and procedure.
- Assist with the ordering, maintenance and replacement of stock and equipment within the department or service area, and to participate in the selection of new equipment.

Educational:

- As a requirement for professional registration (CORU), all staff grades must actively participate in Continuing Professional Development, including keeping up to date with current trends and new technology relevant to ones area of work. This will from time to time include attendance at in- services, workshops, peer learning and courses as agreed by Occupational Therapy Manager.
- Attend and participate in the in-service programme within the department and hospital.
- Assist in the organisation and education of Occupational Therapy students as appropriate.
- Assist in the educating of other professionals and students within the multi-disciplinary team about Occupational Therapy through formal and in-formal methods.
- Participate in activities relating to the evaluation and research of the practice of Occupational Therapy.

Health and Safety:

- Work in accordance with Health and Safety Regulations in St. Vincent's University Hospital.
- Attend CPR training, Fire Safety and Manual Handling training courses as organised by the hospital.
- Take responsibility for the safety and care of all equipment used.

General:

- Attend staff meetings and other scheduled meetings within the Occupational Therapy department or multi-disciplinary team.
- Be involved with department audits, quality assurance and other related projects.
- Undertake any other duties as required by the Occupational Therapy Manager

The above Job Description is not intended to be a comprehensive list of all duties involved and consequently, the post holder may be required to perform other duties as appropriate to the post which may be assigned to him/her from time to time and to contribute to the development of the post while in office. Candidates should expect to be appointed on the minimum of the salary range and in accordance with the Department of Finance guidelines.

Probationary Period: The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

Pension Scheme: The candidate will be entered into one of the Hospital Superannuation Schemes.

Working Hours: The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

Annual leave entitlement: 27 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

Abatement of Pension (Section 52 of Public Service Pensions Act 2012): Where a person who is in receipt of a Public Service Pension (e.g. retired on voluntary age grounds) is subsequently appointed to another Public Service post, the Abatement of Pension Regulations apply. Shortlisting: Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next state of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. It is your responsibility to ensure that you have access to your mobile voice mails and emails. We recommend that you use an email address that you have regular access to.

Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one week's notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be

offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

Disability: Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. SVUH reserves the right to remove candidates from specific recruitment panels and retract job offers if satisfactory clearances cannot be obtained or are deemed unsatisfactory.

** If you lived in any country for 6 months or more from the date of your 16th birthday other than the Republic of Ireland or Northern Ireland you will be required to provide security clearance for each jurisdiction in which you have resided.
