# **Accountability and Working Relationships**

Title: Senior Dietitian - Cancer Care

Reports to: Dietitian Manager / Deputy Dietitian Manager

## **Role Summary:**

To work with other cancer care dietitians as part of the MDT in the development, delivery and evaluation of evidence based nutritional care/pathways to patients undergoing treatment for cancer.

# **Key Duties and Responsibilities:**

- Be responsible for the organisation, provision and evaluation of Nutrition and Dietetic services to patients attending for cancer treatments/survivors of Head and Neck cancer (HNC), Liver cancer and general haematology and oncology services including inpatient, Day and OPD care. Provision of service to the Day Ward will include an extended day (08.00 20.00).
- Oversee development of evidenced based nutritional care pathways for cancer patients, to
  include MDT prehabilitation, inpatient, day care and OPD services and organisation of
  appropriate follow-up, through integration with community services or other acute centres as
  appropriate.
- Develop, implement and monitor a plan of care, based on assessment of the patients' nutritional needs. This may include co-ordination of care for patients requiring home parenteral nutrition (HPN)
- Develop and maintain high standards of evidence based dietetic clinical practice.
- Improve nutritional status of patients to optimise treatment tolerance, and provide nutritional counselling for secondary prevention of recurrence/survivorship.
- Attend MDT meetings for effective interdisciplinary communication and decision-making.
- Liaise with the multidisciplinary team, and dietitians in other healthcare settings as appropriate to ensure continuity and safe care of all patients.
- Ensure appropriate discharge planning in conjunction with patient's families/carers and the multidisciplinary team.
- Liaise with Catering staff regarding the provision of therapeutic diets. Order appropriate nutrition support products as required.
- Participate in service planning, develop the nutrition service to this area and ensure effective use of available resources through continuous improvement and quality management.
- Initiate and actively participate in continuous quality improvement, research and audit in this area.

- Ensure the ongoing review of existing resources; develop and evaluate new resources to support and meet the needs of the service.
- Analyse service demands and develop the dietetic team with other HSCP members in line with evolving requirements including extended working hours.
- Provide leadership to staff grade Dietitians through the process of professional supervision, with a view to enabling the dietitian to identify and develop their clinical knowledge and skills.
- Act as Team leader, prioritising caseloads & allocating to other team members as required.
- Manage clinical risk within own caseload and that of the designated team at all times.
- Develop, implement and evaluate standards and policies within the department of Nutrition and Dietetics.
- Maintain HCRs and statistics in line with the Dept. and hospital policy.
- Carry out any other duties and responsibilities appropriate to the post that may be assigned by the Dietitian Manager.

## Education & Training

- Maintain CPD in line with CORU registration
- Liaise with other professional groups with respect to nutritional education & training, e.g. nursing staff, HSCPs, medical staff, and catering department etc.
- Participate in the development and evaluation of nutrition education resource materials.
- Coordinate and/or provide practice placement education to pre-registration dietitians. Supervise research projects of nutrition or dietetic students.

The above Job Description is not intended to be a comprehensive list of all duties involved and consequently, the post holder may be required to perform other duties as appropriate to the post which may be assigned to him/her from time to time and to contribute to the development of the post while in office. **Probationary Period:** The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

**Pension Scheme:** The candidate will be entered into one of the Hospital Superannuation Schemes.

**Working Hours:** The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

**Annual leave entitlement:** 29 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

**Abatement of Pension (Section 52 of Public Service Pensions Act 2012):** Where a person who is in receipt of a Public Service Pension (e.g. retired on voluntary age grounds) is subsequently appointed to another Public Service post, the Abatement of Pension Regulations apply. **Shortlisting:** Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next state of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. It is your responsibility to ensure that you have access to your mobile voice mails and emails. We recommend that you use an email address that you have regular access to.

Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one weeks' notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

**Disability:** Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)\*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. SVUH reserves the right to remove candidates from specific recruitment panels and retract job offers if satisfactory clearances cannot be obtained or are deemed unsatisfactory.

\* If you lived in any country for 6 months or more from the date of your 16<sup>th</sup> birthday other than the Republic of Ireland or Northern Ireland you will be required to provide security clearance for each jurisdiction in which you have resided.
