**Overview:**

The post holder, in co-operation with the Laboratory Manager, the Consultant Head of Department and Chief Medical Scientist in Histopathology

- Work as part of a team in the provision of a Histopathology service for St. Vincent's University Hospital and its associated institutions and general practitioners in accordance with departmental policy.
- Actively contribute to the operation of a quality management system in compliance with ISO15189 INAB standards in Histopathology which all grades of staff are part of and which provides the governance framework for all processes in the department.
- Co-operate with the Chief Medical Scientist and with other senior personnel in training staff as required.

**Key Duties and Responsibilities**

**General**

- Maintain throughout the Hospital awareness of the primacy of the patient in relation to all hospital activities.
- Participate in developing the Histopathology service to meet the clinical needs of our patients and ensuring that the service is consistent with the mission, vision values and strategic plan of the Hospital.
- Participate in a team of skilled staff, creating and promoting healthy working relationships.
- Participate in the implementation of operational processes to the standards of 'best practice', in order to optimise use of resources.
- Participate in the implementation of a 'quality management' programme, which is patient centred and which measures and audits performance and client satisfaction.
- Actively participate in and promote continuing education and research activities consistent with the values of the Hospital.
- Participate in the concept of open communications throughout the Hospital.

**Service**

- Perform routine work to the highest standards, as determined by the Laboratory Management Team.
- Ensure that all samples are processed in accordance with standard operating procedures.
- Be responsible for the quality of their work and carry out their duties in accordance with Hospital policy.
- Observe the strictest confidence when dealing with all aspects of patient or Hospital information.
- In co-operation with the Consultant Head of Department, Chief Medical Scientist and other designated senior staff, participate in the introduction of new ideas and methods according to hospital policy.
- Ensure that policy relating to the Pathology Laboratory record keeping is followed.
- Co-operate in evaluating assays, equipment, consumable items and research projects where required.
- Participate with the Chief Medical Scientist in facilitating the training of students from relevant college courses.
- Actively participate in internal and external quality control and quality assurance programmes.

## Health & Safety

- Participate in ensuring that effective safety procedures are in place to comply not only with the Safety, Health and Welfare at Work Act but also within the spirit of the Hospital's mission, vision and values, and that they are known and followed.
- Assist and co-operate with the Laboratory Management Team in developing procedures to be followed in preventing and managing accidents occurring in the Laboratory area.

## Professional Development

- Achievement of Laboratory and personal objectives are reviewed annually as part of the Personal Development Planning (PDP) process, which forms the basis for the staff annual joint review meeting with the line manager.

**The appointment is:** Whole time, Permanent and Pensionable.

**Panel:** A panel may be formed to fill upcoming permanent, temporary full and part time vacancies over the next 6 months.

**Annual Salary: Medical Scientist; €44,331 - €73,667 LSI** (01/08/2025), pro rata

These particulars are subject to change in line with overall public pay policy.

**Candidates should expect to be appointed on the minimum of the salary range and in accordance with the Department of Finance guidelines.**

**Probationary Period:** The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

**Pension Scheme:** The candidate will be entered into one of the Hospital Superannuation Schemes.

**Working Hours:** The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

**Annual leave entitlement:** 27 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

**Shortlisting:** Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next state of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one week's notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

**Disability:** Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. For some recruitment competitions a panel of successful candidates may be formed as a result of the interviews.
