## **Accountability and Working Relationships**

**Title:** Senior Dietitian

**Reports to:** Dietitian Manager

### **Role Summary:**

To provide, coordinate, and evaluate a comprehensive nutrition and dietetic service to the Renal Unit with a staff grade Dietitian.

To function as an efficient member of the dietetic and renal teams, with the aim of ensuring optimum delivery of nutrition and dietetic care to patients in St. Vincent's University Hospital. This post holder will provide clinical supervision to the staff grade Dietitian and participate in clinical education placements.

### **Key Duties and Responsibilities:**

- In collaboration with staff grade Dietitian be responsible for the organisation, provision and evaluation of Nutrition and Dietetic services to renal inpatients, renal OPD, haemodialysis and peritoneal dialysis patients.
- Deliver care within the multidisciplinary team approach. To facilitate this approach, attendance at ward rounds, team meetings, and clinical review meetings is essential.
- To organise and prioritise a blanket dietetic referral system for renal patients (as listed above) and audit activity statistics to aid service delivery and development.
- Develop, implement and evaluate policies, protocols and procedures for the assigned areas.
- To work in collaboration with the medical team in the management of metabolic bone disease in the renal patient population.
- To input relevant patient data onto the renal-specific patient information system (E-med) and update it as appropriate.
- To arrange transfer of patient care or referral to Dietitians in other satellite dialysis units as required.
- Work in close co-operation with the Catering Department to ensure patient's nutritional needs are met.
- Order nutritional support products as required by clients/wards. Undertake evaluation of new sip or enteral feeds as required.
- Provide dietetic cover as required for other members of the department during periods of leave.

- Participate/initiate in quality improvements in delivery of care through clinical audit, evaluation and research.

**Education:**

- Initiate and participate in the education/upskilling of dietetic colleagues, other health professionals and patient groups as required.
- Design, prepare, and evaluate educational resources used for both patient and professional education.
- Facilitate/supervise the clinical placement and research projects of pre-registration dietitians.
- To maintain a portfolio of “continuous professional development” in the relevant areas of specialisation.

**Management/Administration:**

- Evaluate and develop services to patients and to advise the Dietitian Manager of future planning requirements.
- Contribute to setting and monitoring performance standards
- Maintain patient records and to collect statistics as required by the department and service.
- Clinically supervise entry-level dietitians and engage in non-managerial clinical supervision.
- Will carry out any other duties deemed appropriate and requested by the Dietitian Manager.

Within budgetary constraints, the department will support a commitment to continuous professional development.

**Probationary Period:** The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

**Pension Scheme:** The candidate will be entered into one of the Hospital Superannuation Schemes.

**Working Hours:** The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

**Annual leave entitlement:** 29 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

**Abatement of Pension (Section 52 of Public Service Pensions Act 2012):** Where a person who is in receipt of a Public Service Pension (e.g. retired on voluntary age grounds) is subsequently appointed to another Public Service post, the Abatement of Pension Regulations apply. **Shortlisting:** Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next stage of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. It is your responsibility to ensure that you have access to your mobile voice mails and emails. We recommend that you use an email address that you have regular access to.

Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one weeks' notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

**Disability:** Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)\*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. SVUH reserves the right to remove candidates from specific recruitment panels and retract job offers if satisfactory clearances cannot be obtained or are deemed unsatisfactory.

*\* If you lived in any country for 6 months or more from the date of your 16<sup>th</sup> birthday other than the Republic of Ireland or Northern Ireland you will be required to provide security clearance for each jurisdiction in which you have resided. Your security clearance must be dated AFTER you left that country and cover the entire period of your residence. Seeking security clearances from other countries are the responsibility of the candidate. It is a process which can take an amount of time.
