## **Accountability and Working Relationships**

**Title:** Grade IV - Facilities Support Services Administrator

**Reports to:** Grade V Facilities Management and Facilities Manager

### **Role Summary:**

The primary duty of this role is to provide administrative support to the Facilities Management. This role also requires strong communication skills, self-motivation, ability to work alone or as part of a team, and problem solving skills.

### **Key Duties and Responsibilities:**

- Ensure efficient administrative support to the Facilities Management Department including cover of the Post and Transport Desk, taking minutes of departmental meetings and preparing presentations for contract review meetings and day to day management of the staff locker rooms.
- Develop and maintain administrative systems for dealing with the completion and tracking of Facilities Management audits. This will include completion of support services checklists and follow up on reports and action plans on behalf of all the services under the General Services remit.
- To carry out all aspects of administration work pertaining to the hospital's bed asset management programme. This will require well-developed decision making and prioritising skills together with the ability to work under pressure whilst balancing multiple tasks.
- Develop and maintain administrative systems for dealing with all correspondence and issues pertaining to the role.
- Maintain a high quality level of communications and working relationships with colleagues; be flexible and adaptable to the working demands of the department.
- Liaise with other departments in the hospital and external agencies where applicable.
- Have a strategic, proactive and flexible approach to work tasks.
- Liaise regularly with the Facilities Management Grade V Officers and Grade VII Facilities Manager for allocation of duties and ensure line management is kept informed of issues.
- Contribute to reviewing and updating Standard Operating Procedures (SOP's) pertinent to the role.
- Assist in the collection and compilation of data, statistics, research and the writing of reports pertaining to the role.
- Ensure that all duties are conducted in a professional and confidential manner.
- Manage workload to ensure that unacceptable backlogs do not occur and timelines are met.
- Carry out any other relevant duties relevant to the post which may be assigned from time to time by the Facilities Management Officers and the Facilities Manager.
- Be familiar with and adhere to the Policies, Procedures and Guidelines (PPG's) for St Vincent's University Hospital.
- Other duties that may arise appropriate to the Facilities Management Department.

## Hygiene/Household Services

- Ensure the efficient day-to-day administration of tasks for the hygiene and environment services. This will require well-developed decision making and prioritising skills together with the ability to work under pressure whilst balancing multiple tasks.
- Be responsible for ensuring that good practice cleaning standards are applied in all areas with emphasis on the elements of hygiene standards (including staff and patient environments, contract cleaning and linen management).
- Complete support services checklists and follow up on action plans and tasks as required for services under the Hygiene and Environment, Household and Facilities Management remits.
- Assist in the collection and compilation of data, monitoring and reporting of service delivery pertaining to the role.
- Actively participate in and carry out 3rd party service monitoring and auditing relevant to the role.
- Engage with external contractors and internal stakeholders for hygiene related services.
- Work closely with colleagues in Facilities Management, IPC and other departments to ensure a high quality customer focused service is provided at all times.
- Complete agreed programme of weekly fire checks for support services ensuring follow up actions with relevant departments
- To represent the department as required, communicating and acting on instructions promptly and with diligence.
- To assist with the management of Staff Rest Rooms, On-call Rooms and Staff Changing Room Facilities.

## Administration

- Carry out administration support for hygiene related meetings including HHQIG, Contractor review meetings etc.
- Assist in the collation and updating of KPI data appropriate to areas of responsibilities (Hygiene and Environment, Household)

**Candidates should expect to be appointed on the minimum of the salary range and in accordance with the Department of Finance guidelines.**

**Probationary Period:** The appointee shall hold office for a probationary period of six months – The Hospital's Probation and Induction policy will apply.

**Pension Scheme:** The candidate will be entered into one of the Hospital Superannuation Schemes.

**Working Hours:** The person appointed will work a basic 35 hour week. You will be required to work the agreed roster / on call arrangements advised to you by your line manager. Your contracted hours of work are liable to change between the hours of 8am – 8pm over seven days to meet the requirements for the extended day services in accordance with the terms of the Framework Agreement. (Reference HSE HR Circular 003/2009). Flexibility on hours of attendance in response to service needs will be a requirement.

**Annual leave entitlement:** 27 days per annum pro rata each year. Annual leave accrued must be taken within the duration of the contract or calendar year and as agreed between the candidate and the Head of Department.

Prospective candidates must satisfy themselves as to their eligibility to be employed applying / competing for posts to be filled through this recruitment campaign.

**Abatement of Pension (Section 52 of Public Service Pensions Act 2012):** Where a person who is in receipt of a Public Service Pension (e.g. retired on voluntary age grounds) is subsequently appointed to another Public Service post, the Abatement of Pension Regulations apply. **Shortlisting:** Shortlisting will be carried out on the basis of information supplied on your curriculum vitae. The criteria for shortlisting are based on the requirements of the post as outlined in the Person Specification. Failure to include information regarding these requirements on your CV may result in you not being called forward to the next state of the recruitment process.

All overseas qualifications must be validated. No candidate can work in the Hospital without validated qualifications. If professional registration is also a requirement, candidates must provide documentation of same.

Canvassing will automatically disqualify.

Please note that you will be contacted mainly by mobile phone and email. It is important that your mobile phone number, postal address and email address are correct. It is your responsibility to ensure that you have access to your mobile voice mails and emails. We recommend that you use an email address that you have regular access to.

Competency based interviews follow the shortlisting stage of the recruitment process. Credit is awarded by the interview panel to candidates who demonstrate at interview that they possess the experience, competencies and skills listed in the person specification. Candidates will normally be given at least one weeks' notice of interview. All interviews are held in person unless it is specifically noted otherwise in the Job Description. No subsequent or alternative dates to dates given will be offered to candidates. All posts are located in St. Vincent's University Hospital, Elm Park, Dublin 4 unless it is specifically noted otherwise in the Job Description.

**Disability:** Please let us know if you need any special assistance at interview, e.g. if you have difficulty in moving up or down stairs or have hearing or speech difficulties.

Candidates are notified of the result of their interview at the earliest possible date after the interview. The recommendation of the interview panel does not constitute a job offer. The process continues after the interview and includes clearance checks such as references, Garda clearance, overseas police clearance (if applicable)\*, occupational health clearance, validation of qualifications and experience. A job offer is made pending satisfactory clearances. *\* If you lived in any country for 6 months or more from the date of your 16<sup>th</sup> birthday other than the Republic of Ireland or Northern Ireland you will be required to provide security clearance for each jurisdiction in which you have resided. Your security clearance must be dated AFTER you left that country and cover the entire period of your residence.
